### 17 INDICTED ON FEDERAL DRUG CHARGES



The Warren County Drug Task Force, the Drug Enforcement Administration (Dayton), and the Ohio Bureau of Criminal Investigation have participated in a joint investigation involving the trafficking of thousands of pounds of marijuana in Southwest Ohio.

A Federal Grand Jury in Dayton has indicted seventeen subjects for Conspiracy to Distribute Controlled Substances, whose sources are in Arizona and Mexico. Some of these individuals have already received service on their indictments prior to today, with additional subjects being sought for arrest.

The conspiracy has been intact since approximately 1998, and involves individuals in Warren, Preble, Butler, Adams, and Montgomery counties in Ohio, and the southern region of Arizona, with ultimate ties to Mexico.

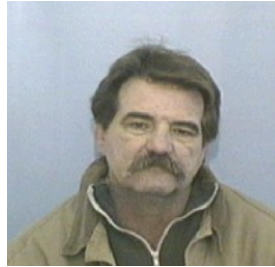
Also seized in this operation is over \$1.0 million dollars in real estate in Arizona, and approximately \$500,000 in U.S. Currency, real estate, vehicles, and other property in Southwest Ohio. 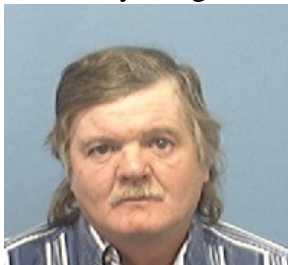
