The Greater Warren County Drug Task Force is completing a large sweep of drug traffickers in Warren, Butler, and Montgomery counties, in addition to Wilmington, Ohio.

Although these defendants are not necessarily associates, these investigations have been ongoing for the past six months, and include traffickers in cocaine, marijuana, prescription drugs, methamphetamine, and heroin.

In all, (23) defendants are the subject of sealed indictments that were attempted to be served this morning. A comprehensive list of those defendants is attached, that include the indication as to whether they have been arrested or are still at large. **We are soliciting any assistance from the general public that may know the whereabouts of those still wanted.**

PHYSICIAN PLEADS GUILTY TO CONSPIRACY FOR HIS ROLE IN ILLEGAL PRESCRIPTION DRUG DISTRIBUTION

DAYTON – Dr. Richard Sievers, 53, of Oakwood, pleaded guilty in United States District Court here today to one count of conspiracy for his participation in a scheme that resulted in the illegal distribution of more than 700,000 dosage units of controlled substances from a storefront medical clinic in Dayton between January and November 2007.

Gregory G. Lockhart, United States Attorney for the Southern District of Ohio, Todd Spradling, Resident Agent in Charge, Drug Enforcement Administration (DEA), Dayton Field Office, Keith L. Bennett, Special Agent in Charge, Federal Bureau of Investigation, and Commander John Burke of the Warren County Drug Task Force announced the plea entered today before U.S. District Judge Thomas M. Rose.

According to court documents, Sievers operated Walnut Hills Family Care, located at 1900 Wayne Avenue in Dayton. Sievers conspired with others to distribute prescription drugs including Amphetamine, OxyContin (oxycodone), Vicodin ES (hydrocodone), Xanax (alprazolam), and Methadone (methadone).

Sievers wrote or approved prescriptions that were not issued for a legitimate medical purpose and were not in the usual course of his medical practice. In particular, the "patients" were not given proper medical examinations prior to the issuance of the prescriptions for the controlled substances. The "patients" would then provide money in return for the issuance of the prescriptions. The "patients" picked up the prescriptions at Walnut Hills Family Care.

Conspiracy to distribute controlled substances is punishable by up to 20 years imprisonment. Judge Rose will set a date for sentencing. Sievers is the ninth person who has pleaded guilty to participating in the conspiracy. All are awaiting sentencing.

Lockhart commended the cooperative investigation by the agents and officers, and Assistant U.S. Attorney Sheila Lafferty, who is prosecuting the case. The DEA Dayton Resident Office and the Warren County Drug Task Force began the investigation. Agencies participating in the investigation include the Dayton Police Department, the Montgomery County Sheriff's Office, the Ohio State Board of Pharmacy, the Ohio State Medical Board and the U.S. Postal Inspection Service.
